**Assignment Title: Consultancy Services for Design and Development of Training Programme for City Transport Professionals**

The Government of India (GoI) has received a grant from the Global Environment Facility (GEF)/ World Bank towards the cost of the ESCBS Project and intends to apply part of the proceeds for consulting services.

The consulting services ("the Services") include Design and Development of Training Programme for City Transport Professionals. **The period of services shall be 15 months.**

The broad scope of work for this assignment involves (a) review of assessed training needs for any additions and develop a final list of the relevant training toolkits to be prepared under the assignment, (b) design and development of training programs, (c) evaluate the effectiveness of the training programme conducted and preparation of a Project Completion Report. The draft Terms of Reference (ToR) is available on the website <http://eprocure.gov.in>, <http://moud.gov.in> and <http://www.sutpindia.com>.

Ministry of Housing and Urban Affairs (MoHUA) now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested consultants/firms should provide information demonstrating that they have the required qualifications and relevant experience to perform the services.

**The EoIs were received earlier on 07.08.2017. As insufficient number of EoIs were received, it has been decided to re-invite Expression of Interest from consulting firms afresh.**

**Consultants/ firms which had submitted their EoIs in the earlier round are advised to submit their EoI afresh, in response to this notice as the previous response to the e-tender received on 07.08.2017 will not be considered.**

The shortlisting criteria are:

1. The firm should have an average annual financial turnover of at least INR 10 crore in the last 3 years;
2. Experience in Design & preparation of training programs and materials for practitioners;
3. Knowledge and experience in area of city transport sector.



Expression of Interest (EoI) must include but not limited to:


- Introductory letter on letter head (with complete contact details – name of contact person, mailing address, telephone, fax, e-mail etc.) explaining how the firm is best to deliver the task;
- Organization profile;
- Last three years' annual report including audited financial statement;
- Short note on the similar projects implemented by the firm along with the reference/client list and description of assignments handled pertaining to the shortlisting criteria;
- The EoI should contain sufficient supporting documents to substantiate the claim of the consultant towards their qualification as per the short listing criteria.

Attention of interested consultants/ firms is drawn to paragraph 1.9 of the World Bank's Guidelines: Selection and Employment of Consultants [under IBRD Loans and IDA Credits & Grants, January, 2011] by World Bank Borrowers ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest.

The Consultants may associate with other firms in the form of a joint venture (JV) or a sub-consultancy to enhance their qualifications. Such association must be clearly stated in the EoI as either JV or Sub-consultant.

A Consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method set out in the Consultant Guidelines.
