1. This Request for Expressions of Interest follows the general procurement notice for this project that appeared in Development Business, issue on 1 October 2008
2. The Ministry of Urban Development has received a grant from the Global Environment Fund (GEF)/ International Bank for Reconstruction and Development and intends to apply part of the proceeds of this grant to payments under the contract for '**Consultancy Services to Develop Guidance Documents for NMT Plan, Bike Sharing Scheme and Transit Oriented Development**'.
3. The objective of this consultancy are to develop **guidance documents** for the following urban transport reforms:
 - (i) Developing a comprehensive Non-Motorised Transport (NMT) plan for a city;
 - (ii) Designing a Public Bike Sharing Scheme; and
 - (iii) Developing a plan for Transit Oriented Development (TOD) in a city.

In addition, the consultant must conduct capacity-building workshops to encourage interested cities in implementing the reforms. The duration of the consultancy services is expected to be 12 months from the date of award of the contract.
