1. This Request for Expressions of Interest follows the general procurement notice for this project that appeared in Development Business, issue number 737 on 1 October 2008.
2. The Government of India has received a grant from the Global Environment Facility (GEF)/ International Bank for Reconstruction and Development and intends to apply part of the proceeds of this grant to payments under the contract for Technical Consultancy for Monitoring and Evaluation of Pimpri Chinchwad BRT Corridors.
3. Pimpri-Chinchwad Municipal Corporation (PCMC) has availed funds to improve urban transport infrastructure and services in corporation area. These investments are expected to promote environmentally sustainable transport and reduce green house gas emissions in the city. The project consists of implementing Bus Rapid Transit Corridors in PCMC Area.
4. PCMC seeks to hire Consultants for Project Monitoring and Evaluation (M&E) to identify performance indicators and track the impact of the project before, during and after through various identified performance indicators; assess the impact of the project by tracking if the objectives of schedule adherence, cost reduction, efficiency and customer satisfaction are achieved and track the outcome and intermediate outcome indicators.

The duration of the project monitoring and evaluation consultancy is expected to be 48 months from the date of award of the contract.

5. The Pimpri Chinchwad Municipal Corporation now invites eligible consultants to indicate their interest in providing the Services. Interested consultants must provide information indicating that they are qualified to perform the Services (brochures, description of similar

assignments, experience in similar conditions, availability of appropriate skills among staff etc).
